Additionally, it was time to discuss the main conclusions from the survey on the Pillars in order to understand the improvements required and strategies to follow. ASC MEETING – 14th MARCH

This first meeting of the ASC was the occasion to listen to the current **Pillar Coordinators**, who **play a key role in energising the strategy and liaising between the public and private sectors and academia** on all issues related to the different thematic areas of the strategy.

The Atlantic Assistance Mechanism (AAM) presented the **2021 implementation report of the Atlantic Action Plan 2.0**.

This is the **first report endorsed by the ASC since the adoption of the Plan in July 2020**. The report provides a comprehensive **overview of all activities undertaken and the results of the first year** of implementation. The content was based on research and information gathered by the AAM in cooperation with pillar coordinators and task forces members, and with the assistance of the ASC representatives.


The ASC Presidency underlined the **need to reinforce the operational structure of the new Atlantic Action Plan (AAP).** To this end, they will seek an active and central role for the Atlantic strategy in the development of the Atlantic sea basin. In order to improve the governance of the AAP, the ASC will work towards the creation of an agile and transparent operational framework.

The presentation highlighted the **central role played** by the Pillar Coordinators in preparing the roadmaps, identifying opportunities and obstacles, collecting information, creating Atlantic networks and organising task force meetings and workshops addressing relevant issues to the pillars of the action plan.

The AAM presented the results of a survey on the work carried out by the Pillar Coordinators over the last year.

The AAM together with the Spanish Presidency, CINEA and DG MARE carried out an evaluation of the first year of implementation of the Action Plan 2.0. One of the conclusions is that it is **crucial that the Pillar Coordinators feel part of the process**, so it is needed to receive feedback from the stakeholders who are implementing the Atlantic Action Plan in order to prepare the next course of action for future implementations.


